Together with the right to use in common with others, the waters of Upper Greenwood Lake for boating, bathing and fishing.

The right to use Upper Greenwood Lake for boating, bathing and fishing is subject to the rights of the adjoining owners, to use the said waters for like purposes and also subject to the future rights, if any, of any municipal corporation to use and draw out the waters of said lake for municipal purposes and also subject to such sanitary regulations as the State of New Jersey, of any county, town or municipal authority of said State of New Jersey make make regarding the said land or the use of the waters therein.

The right, title and interest in the roads, streets or avenues herein conveyed is subject to the right of the grantor of the party of the first part, which right is hereby reserved, to allow the erection, installation and maintenance within the beds or at the sides of said streets, roads or avenues, of water, gas pipes, mains, valves etc. as well as telephone and telegraph poles, lines and necessary equipment for the transmission of electricity.

Subject also to the mine and mineral rights, if any, and also subject to the restrictions, easements and rights of way of record and the restrictions, conditions and

covenants hereinafter expressed.

This conveyance is made by the party of the first part to the party of the second part, upon the express covenant and condition to which the party of the second part by the acceptance of this deed agrees; that it, the said Association will at all times pay all taxes and assessments which may will at all times pay all taxes and assessments which may hereafter be assessed, levied or imposed upon the lands hereafter be assessed, levied or imposed upon the lands and buildings in this deed mentioned, as and when same shall become due and payable.

And the said Association will at all times properly keep and maintain the said Club House for the benefit and use of the members of said Association as a Club House or social center or for general recreation purposes.

And that the said Association will at all times keep, maintain and improve the parks and other property herein conveyed for the benefit and use of the residents and lot owners at Upper Greenwood Lake.

As and when the said Upper Greenwood Lake shall become a municipal corporation under the laws of the State of New Jersey, said Association will, upon the agreement of said Jersey, said Association to keep and maintain the said property municipal corporation to keep and maintain the said property for the benefit of the residents and lot owners of Upper for the benefit of the residents and lot owners of Upper Greenwood Lake, transfer and convey unto said municipal corporation, without any cost or charge to said muncipal corporation, the legal and equitable title to the real property above mentioned.

The said Association will not otherwise sell, transfer or dispose of the said real property or any part thereof, nor will it mortgage, pledge or otherwise encumber the same or any part thereof.

The conditions above stated shall be covenants running with the land, with the right of re-entry to the said party of the first part, or its successors or assigns, for the breach of any or all of said covenants, provided, however, breach of ight of re-entry shall not be available against that said right Corporation.
