Meeting was to discuss application submitted by the property owner(s) to repair current bulkhead. In the committee's opinion the bulkhead cannot be properly worked on until the next lake drawdown. Alternatives were discussed with the property owner, which would provide a temporary deck over the current failing bulkhead to safely give them access to their dock and boat.

A motion was made at 9:45pm by Heather Becker, seconded by Jessica Nicosia, to allow 239 Point Breeze to build a 6.5-7' deep by 15' long temporary deck over the failing bulkhead, to be replaced by a conforming bulkhead and dock during the next drawdown.
